The other two types of establishments can be dealt with if they come to our area. This Business License Tax structure has been reviewed by Nye County DA's office and per NRS 269 the Town can fix a separate business license tax per each different business model within the Medical Marijuana Industry based upon the amount of business done or type. Subject to final review of changes to ordinance. The Distribution of the Medical Marijuana Tax Revenue will be decided at a future meeting.
